Through this agenda, the Caucus is focused on promoting homeownership, tenant protections, home safety, and senior housing. Unfortunately, Black, Latino, and Asian New Yorkers often encounter obstacles to accessing affordable housing due to factors such as discrimination, language barriers, and income inequality. This body is dedicated to ensuring that all New Yorkers have equal access to high-quality housing that meets their needs. Access to affordable, safe, and stable housing is critical for achieving educational success, ensuring public safety, and promoting community wellness.

THE PEOPLE'S HEALTH POLICY AGENDA

Promoting health equity and addressing racial health disparities is essential for improving health outcomes for all New Yorkers. The Caucus will continue to prioritize policies that emphasize lead remediation and prevention measures, maternal health support, tackling high prescription drug prices, and ending medical debt. Additionally, mental health is a critical component of overall health and well-being. This year, the Caucus will focus on fostering innovation, supporting small businesses, and creating diverse job opportunities to drive sustainable economic growth across the state.

THE PEOPLE'S FAMILY, HUMAN SERVICES & IMMIGRATION POLICY AGENDA

To build safe and resilient communities, it is crucial to prioritize the well-being of New York families. The Caucus recognizes the need to address issues related to the family court system and the separation of families of color. Moreover, the members will advocate for legislation that expands community intervention resources, support services, and evidence-based approaches to prevent violence and create secure environments for all families. Additionally, the body is dedicated to championing policies that protect the rights of immigrants, including access to education, legal representation, and protection from discrimination. By focusing on these priorities, the Caucus aims to create a strong safety net system that ensures the stability and wellbeing of all New Yorkers, especially vulnerable communities.

THE PEOPLE'S ENVIRONMENTAL JUSTICE & ENERGY POLICY AGENDA

The Caucus prioritizes enhancing environmental health in marginalized communities by tackling toxic exposures, minimizing pollution sources, and promoting a fair shift away from fossil fuels. Furthermore, the Caucus champions policies that guarantee Black, Latino, and AAPI New Yorkers access to essential resources for a healthy life, such as safe and nutritious food and clean drinking water. By addressing these vital needs, the Caucus strives to create a more equitable and sustainable environment for all state residents.

Additionally, protecting the data of our children is a crucial priority to safeguard their privacy and rights. The Caucus is dedicated to these legislative efforts, striving to create a New York society that upholds civil rights, promotes justice, and treats everyone with dignity and respect under the law.

A7261/S600 – Oversight of Juvenile Detention Facilities - Protecting the rights and welfare of young people in custody is paramount. This bill establishes crucial civilian oversight of juvenile detention facilities, ensuring appropriate care and support for these vulnerable youth

A908/S1233 - Increases access to substance abuse programming for incarcerated individuals whose first language is not English

A2539/S5087 - Requires certain justices and judges to visit the correctional facility with the highest population in the county in which such justice or judge was elected or appointed

A1645/S2304 - Requires a reading proficiency level assessment and dyslexia screening for certain incarcerated individuals

A6487/S181 - Expands who may visit local correctional facilities to include accompanying staff of legislative members and members of the department of corrections and community supervision requested by a legislative member
